### 1 Introduction

This CIUS-AT-GOV builds on top of CIUS-AT-NAT. All rules of the underlying specification apply with the addition of the rules stated in this document.

### 2 Identifying CIUS-AT-GOV

### 3 New rules imposed by this CIUS

- Buyer reference becomes mandatory (BT-10)
- Seller contact becomes mandatory (BG-6)
- Seller contact email address becomes mandatory (BT-43)
- Payment means type code is limited to 30, 31, 42, 49, 58, 59 (BT-81)
- Amount due for payment must be  $\leq 999.999.999,99$  (BT-115)
- A maximum of 200 supporting documents can be handled (BG-24)
- The maximum size of all attachments together must not exceed 15 MB (BT-125)
- Only certain Attached document Mime codes are accepted: (BT-125)

- application/pdf,
- image/png
- text/xml
- application/xml
- applicaton/vnd.ms-excel
- applicaton/vnd.openxmlformats-officedocument.spreadsheetml.sheet
- Only certain Attached document Filename extensions are allowed: .pdf, .png, .xml, .xls, .xlsx (BT-125)
- Number of invoice lines must be  $\leq 999$  (BG-25)
- The Invoice line gross amount of a single invoice line must be  $\geq -999.999.999.999,99$  and  $\leq 999.999.999.999,99$  (BT-131)
- The Referenced purchase order line reference (per line item) must be present when the OrderID is 10 digit numeric (BT-132)
